- Four photos of current artwork and one photo of the artist's booth for jurying, a description of media and materials used, and a short bio.
- Payment by check, credit card or money order. **Note: If paying by credit card, please include Credit Card Authorization Form.** Do not post date any checks.
- SASE for Show Acceptance mailed back to you. Checks will be returned to you if not accepted.

Notes: Return check fee is \$25 each. All refunds will be paid by check. Cancellations must be made by 45 days in advance and charged a \$25 fee to cancel.
