- Completed, signed and dated Application Form
- Completed, signed and dated Guild Membership and Volunteer Form
- Completed City of Santa Fe Special Events License Application Form. This is required even though you may have a Events License from another show. NNMFA&C pays the \$10 fee for your Events License. We will obtain and give you your Event License to display at your booth on the first day of your show. The city wants us to submit all license applications as a group and does not want them individually.
- Three photos of current artwork with a description of media and materials used and a short Bio of education including a summary of show and gallery experience (not an artist statement).
- One photo of the artist's booth for jurying & placement
- Payment by check, credit card or money order.

Note: If paying by credit card, please include Credit Card Authorization Form.

- MUST** enclose self addressed stamped business envelope (**SASE**) for application results mailed back to you.

Notes: Postcards (cost is included in your booth fee) will be delivered to hotels by volunteers prior to each show. Show cancellations must be made 45 days in advance and charged a \$45 fee per show to cancel. Returned check fee is \$30.
